

SUMMARY ANNUAL REPORT FOR DEFINED CONTRIBUTION RETIREMENT PLAN OF MOSES CONE HEALTH SYSTEM

This is a summary of the annual report for the DEFINED CONTRIBUTION RETIREMENT PLAN OF MOSES CONE HEALTH SYSTEM, EIN 58-1588823, Plan 002, for period January 1, 2020, through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$14,913,582. These expenses included \$112,821 in administrative expenses and \$14,800,761 in benefits paid to participants and beneficiaries. A total of 12472 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$225,183,689 as of December 31, 2020, compared to \$192,690,637 as of January 1, 2020. During the plan year, the plan experienced an increase in its net assets of \$32,493,052. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$47,406,634, including employer contributions of \$18,468,428, other contributions of \$17,470 and earnings from investments of \$28,920,736.
