

Travel budget checklist.

A great way to keep this account's money separate is by opening a new, high-interest savings account and setting up automatic payments from your paycheck to it. Research ways to travel more cheaply. For example, traveling during the off-season or by swapping houses with a friend to save on housing. If you are finding it hard to fund your new travel savings account, consider taking on a side job to bring in a little extra cash. Consider talking to a financial professional who can help you look at your finances and make suggestions based on all of your financial goals. Don't forget to include expenditures on visas, travel insurance and vaccinations, if you plan to travel overseas. Research the countries you want to explore by starting with your country's foreign affairs office. Be flexible about where you want to travel.
