Participants receive an offsetting reduction in the separate account fee as applicable to amounts allocated to that fund option.
- Other Expenses include expenses related to administrative and shareholder services provided to the fund, such as accounting, audit, compliance, custody, legal and other shareholder-related services.
- Acquired Fund Fees and Expenses apply to a fund that invests in underlying funds and reflects the relevant portion of the fees for those
